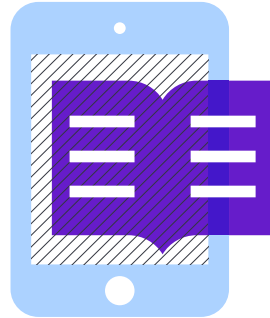

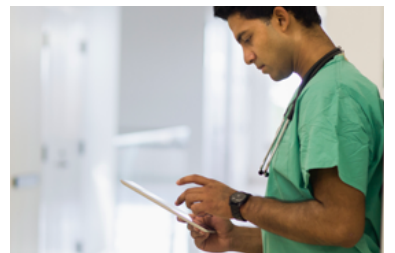
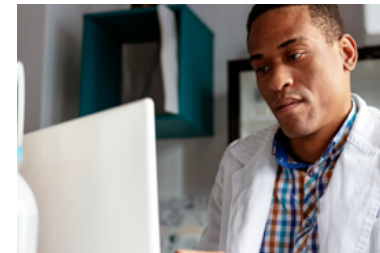
The world is changing: COVID-19 has meant fewer in-person conferences and patient consultations, and a greater need for online resources. Physicians are spending:

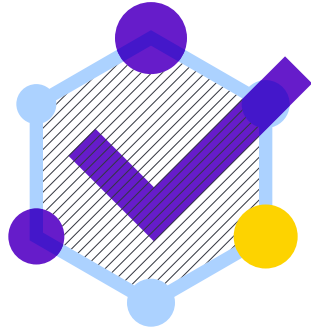

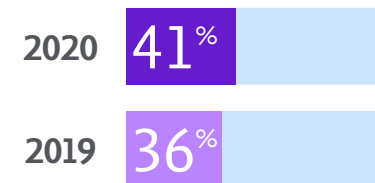

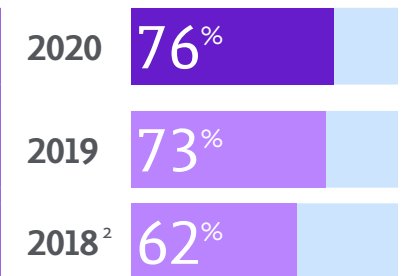
